The Candidates must check his/her eligibility before applying for the course.

**Refund Rules:**

If a student chooses to withdraw from the program of study in which he / she is enrolled, the institution shall follow the following five-tier system for the refund of fees\* remitted by the student.

Sr. No.	Percentage of Refund of Fees*	Point of time when notice of withdrawal of admission is received in the Higher Educational Institutions (HEI)
(1)	100%	15 days or more <b>before</b> the formally-notified last date of admission <b>(on or before 16<sup>th</sup> August 2022)</b>
(2)	90%	Less than 15 days <b>before</b> the formally-notified last date of admission <b>(from 17<sup>th</sup> August 2022 to 1<sup>st</sup> September 2022)</b>
(3)	80%	15 days or less <b>after</b> the formally-notified last date of admission <b>(from 2<sup>nd</sup> September 2022 to 16<sup>th</sup> September 2022)</b>
(4)	50%	30 days or less, but more than 15 days, <b>after</b> formally-notified last date of admission <b>(from 17<sup>th</sup> September 2022 to 1<sup>st</sup> October 2022)</b>
(5)	00%	More than 30 days <b>after</b> formally-notified last date of admission <b>(from 2<sup>nd</sup> October 2022 onwards)</b>

In case of (1) in the table above, the deduction will be 5% of the fees paid as processing charges from the refundable amount subject to maximum of Rs.5000/-
